Conforme Carta DLB 30060.021/2023, datada de 27.10.2023, a partir de 16.10.2023 os serviços do presente Contrato passaram a fazer jus a mais um reajustamento de preços, em estrita consonância com o disposto na Cláusula Décima-Segunda do Contrato e na Legislação (artigo 3º, §1º, da Lei 10.192/2001, e artigo 65, §8º, da Lei nº 8.666/93), além dos entendimentos das Partes previstos no Processo Administrativo 9741/2023.

No dia 02.04.2024, a DELURB recebeu desta ilustre Secretaria um e-mail solicitando o encaminhamento de uma correspondência manifestando a concordância com os cálculos de reajustamento realizados pela Secretaria Municipal de Auditoria e Controle Interno – SEMACI, acostados à fl. 567 do Processo Administrativo 54.170/2023, referente à incidência de 3,85% (três vírgula oitenta e cinco por cento) sobre o preço total do contrato, que passou a somar R\$ 9.475.559,37 (nove milhões, quatrocentos e setenta e cinco mil, quinhentos e cinquenta e nove reais e trinta e sete centavos).

Diante disso, a DELURB manifesta a sua concordância com o reajuste de preços de 3,85% calculado pela SEMACI, disposto à fl. 557 do PA 54.170/2023, a ser aplicados aos serviços prestados a partir de 16.10.2023, passando o preço total do contrato para R\$ 9.475.559,37, ressaltando-se, outrossim, todos os direitos contratuais e legais que a Contratada fizer jus, relacionados, mas não se limitando, à manutenção do equilíbrio econômico-financeiro do contrato.

Art. 3º Os contratos em que seja parte órgão ou entidade da Administração Pública direta ou indireta da União, dos Estados, do Distrito Federal e dos Municípios, serão reajustados ou corrigidos monetariamente de acordo com as disposições desta Lei, e, no que com ela não conflitarem, da Lei nº 8.666, de 21 de junho de 1993.

1º A periodicidade anual nos contratos de que trata o caput deste artigo será contada a partir da data limite para apresentação da proposta ou do orçamento a que essa se referir.

Art. 65. Os contratos regidos por esta Lei poderão ser alterados, com as devidas justificativas, nos seguintes casos:

8º A variação do valor contratual para fazer face ao reajuste de preços previsto no próprio contrato, as atualizações, compensações ou anulações financeiras decorrentes das condições de pagamento nele previstas, bem como o empenho de dotações orçamentárias suplementares até o limite do seu valor corrigido, não caracterizam alteração do mesmo, podendo ser registrados por simples apostila, dispensando a celebração de aditamento.

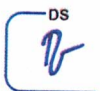
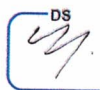

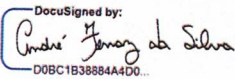
